Costs can differ widely if intended parents decide to utilize any additional or special service, for example, if there is sperm washing involved or if the intended parents need to use Preimplementation Genetic Diagnoses (PGD). Additional fees for these services will be applied accordingly. Therefore, each program is evaluated and planned carefully, based on each participant's requirements.


